

Information on the protection and processing of personal data by KHS Trade Ltd.

- GDPR Regulation

KHS Trade sro, with its registered office at Husinecká 903/10, 130 00 Praha 3, Žižkov, ID: 29267218, contact person Jan Skácal, email: info@khstrade.cz, as the controller of the personal data that will or will be closed contracts provided, obtains from publicly accessible registers, undertakes to process such personal data in accordance with the law, in particular Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (GDPR).

The administrator can process the customer's identification data (especially name, surname, company, residence, registered office, date of birth, personal identification number, ID, VAT number), contact details (especially contact address, telephone, e-mail address, personal data from public registers (especially trade, business, insolvency register, real estate register), personal data resulting from a contractual relationship (especially data on concluded contracts, provided services, duration, customer payment history). The legal reason for the processing of the customer's personal data is the performance of the concluded contract, fulfillment of the statutory obligations of the administrator (especially archiving, accounting and tax records); it is necessary for the purposes of the legitimate interests of the trustee (in particular the handling of complaints, complaints, after-care of the customer). For this processing, the administrator does not need the customer's consent.

Therefore, the customer's right to withdraw consent to the processing of personal data at any time does not apply. Customer's personal data will not be passed on to third parties without the explicit consent of the customer, except for the performance of the contract and the fulfillment of legal obligations vis-à-vis public authorities on the basis of their legal authority. Personal data are not subject to automated decision making, including profiling. Personal data will be processed by the trustee for the duration of the contract. After the expiration of the contract and the claims related to the performance of the connected contract, these data will be handled according to the valid legal regulation, especially Act No. 499/2004 Coll. (Act on Archival and File Service and on the amendment of certain Acts) and the GDPR Regulation. The Customer has the following rights in relation to the processing of personal data: The right of access to personal data means that the customer has the right to obtain information from the trustee about the processing of his or her personal data and, if so, what information is involved and how processed. The customer is also entitled to have the administrator, without undue delay, correct the inaccurate personal data on his / her request. Incomplete personal data has the customer the right to add at any time.

The right to delete personal data is the responsibility of the trustee to liquidate the customer's personal data, unless legal obstacles such as compliance with the statutory obligations of the trustee hinder it and the customer asks for it. The customer has the right to limit the processing of his or her personal data in certain cases. Customer has the right to object at any time against processing that is based on the legitimate interests of the trustee or is necessary for the performance of public interest or public authority duties. The right to data portability gives the customer the ability to obtain personal information provided by administrators in common and machine-readable form, and then pass them on to another manager or, if technically possible, request that they be handed over by the trustee. In the event that the customer is dissatisfied with the processing of his or her personal data by the administrator/trustee, he may complain directly with him / her or contact the Office for Personal Data Protection.
